POSITION SUMMARY

The primary focus of the Product Configuration Developer's role is to streamline Patterson's processing and handling of customer inquiries through creation and maintenance of the software interfaces used for standard product offerings. This role will participate in many cross-functional efforts and will be expected to build consensus among various functional teams to determine the best approach for the company and our customers. This role will have exposure to virtually all functional teams within Patterson, with the heaviest focuses being on Sales, Engineering, and Manufacturing.

- Write, edit, revise, and maintain rule sets for the configurator for various product lines.
- Troubleshoot errors in the rule sets when they occur.
- Create, modify, and oversee data value lookup tables within configurator software based upon input from Sales, Engineering, and Manufacturing
 - o Ensure personnel in each area are trained to maintain these values
 - These values may include but are not limited to pricing, discounts, bills of material, technical documents, work instructions, and routing steps / times / work centers.
- Identify obstacles / shortcomings within configured product structure; lead cross-functional teams to resolve these issues.
- Develop tools / techniques to allow for easy reporting of data from configurator

- Assist in streamlining various processes related to configuration including:
 - o Pricing
 - Inventorying
 - Forecasting
 - Operation
- Ensure configurator meshes seamlessly with other Marketing assets (pump selection software, website, and all other front-end Sales tool, etc.)
- Participate and lead efforts to expand configuration into additional product lines
- Participate and lead efforts to expand the depth of configuration into areas such as:
 - o 2D and 3D CAD images
 - Spec sheets
 - Manuals
 - Custom Quote / submittal packages
 - Configurable repair items
 - On-line parts ordering of configured items
- Stay current with latest configuration technology / approaches and implement improvements when and where justified.
- Drive configuration toward standardization / consistency across various product lines by incorporating best practices learned.
- Load and edit item coding as necessary.
- Participate as a standing member of the Syteline Team and lead "configuration team"
- Good understanding of the relationship between customer configuration experience and the technical needs of the company
- Participate in the product development process and the methods by which the products will be presented to customers. Could include conducting webinars or other training sessions for company employees and distribution on use of configuration tools.
- Solicit and adopt feedback from internal and external customers as appropriate to continually improve configuration process.
