WHAT PERSONAL DATA DO WE COLLECT?

We collect personal data from you when you fill out a form on this website. All supplied personal data is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our database to be accessed only by those authorized with special access rights to our systems, and who are required to keep the personal data confidential.

DO WE USE COOKIES?

Cookies are maintained during active user sessions in order to manage contents of shopping carts where applicable. Additionally, our website uses Google Analytics in order to help us understand website traffic and webpage usage. Google Analytics does not identify individual users or associate your IP address with any other data held by Google. You may refuse the use of cookies by selecting the appropriate settings on your browser, however please note that if you do this you may not be able to use the full functionality of the website.

DO WE DISCLOSE ANY PERSONAL DATA TO OUTSIDE PARTIES?
